NUC University Florida Technical College Consolidates and Renews Lease at SouthPlace City Center Amidst Major Redevelopment

Cutler Bay, Fla. - (June 3, 2025) – American Landmark Apartments, BH Group, and Urban Retail Properties, LLC, are proud to announce the lease renewal of NUC University Florida Technical College (NUC FTC) at SouthPlace City Center, formerly Southland Mall, in Cutler Bay, Florida. The college will consolidate its operations into a new 30,000-square-foot facility within the reimagined mixed-use development, bringing all its programs under one roof to better serve students and the community.

This strategic move aligns with the \$1.5 billion transformation of SouthPlace City Center into a vibrant, mixed-use hub. The redevelopment includes over 5,000 residential units, 500,000 square feet of retail and dining space, a 60,000-square-foot medical center, a 150-room hotel, and extensive green spaces.

"NUC University Florida Technical College has been an integral part of the community, and we're thrilled to support their expansion within SouthPlace City Center," said Paul Motta, COO of Urban Retail Properties. "By consolidating their locations in the existing mall to this 30,000 SF facility, they prove their commitment to education and workforce development, which aligns perfectly with our vision of creating a live-work-play environment that benefits all residents."

NUC University Florida Technical College has served students for over 40 years with diploma and bachelor's degree programs in fields such as healthcare, hospitality, construction trades, and business. The new facility at SouthPlace City Center will provide expanded space to grow its offerings and enhance student services.

Located at 20505 S Dixie Hwy, construction of the new NUC FTC facility is set to commence later this year, with completion anticipated in Spring of 2026, coinciding with the broader redevelopment timeline of SouthPlace City Center. NUC FTC's current locations inside Southland Mall will remain open until the grand opening of their new facility.

"SouthPlace City Center represents a transformative investment in Cutler Bay's future," said Ron Gaither, Chief Development Officer of Electra America. "In partnership with BH Group, we anticipate creating approximately 3,000 new jobs during construction and generating \$44 million in revenue within the first five years, followed by 2,000

permanent jobs. With a reimagined retail center, improved parking, and dedicated community spaces for concerts and farmers' markets, this 100-acre development reinforces Cutler Bay's role as a dynamic hub for both residential and commercial growth."

SouthPlace City Center's current major retailers include Macy's, JCPenney, Regal Cinemas, NUC University Florida Technical College, TJ Maxx, Old Navy, DSW, ROSS Dress for Less, LA Fitness, Five Below, Olive Garden, Buffalo Wild Wings, and Applebee's.
